# CAESARS WINDSOR MILLION DOLLAR GIVEAWAY CONTEST JULY 2, 9, 16, 23 & 30, 2016 RULES AND REGULATIONS ("CONTEST RULES")

The Caesars Windsor's Million Dollar Giveaway Contest is taking place Saturdays in July 2016 at Caesars Windsor. The Promotion consists of a Drawing. For more information about the Promotion, visit http://www.caesarswindsor.com/bigpromo or the Total Rewards Centre at Caesars Windsor.

### 1. How to Enter

**No purchase necessary.** Caesars Windsor's Million Dollar Giveaway Contest (the "Contest") begins on June 19, 2016 at 12:00:00 a.m. Eastern Time ("ET") and ends on July 30, 2016 at approximately 10:30:00 p.m. ET. ("Promotional Period") The Contest includes draws on July 2, 9, 16, 23 & 30, 2016 (each a "Draw Date" or collectively known as "Draw Dates").

Eligible Total Rewards® Members ("Members") will receive a mailed notice (using the last known address recorded on their Total Rewards account) advising them of their eligibility to receive base entries ("Base Entries") (requiring activation as defined below) into the Contest on each Draw Date. The number of Base Entries that a Member is eligible to receive is based on his/her recognized tier status defined by Total Rewards as of June 1, 2016. Base entries for each tier are defined below:

Redeemed Lump Sum Entries will accumulate over the course of the Promotional Period.

Invited qualified guests who reside in Ohio and have the offer only are advised of their eligibility to receive Bonus Entries ("Bonus Entries"). These guests will have available 100 Bonus Entries each draw date for activation and entry into a draw. Bonus Entries must be redeemed between 10:00:00 a.m. ET and 9:00:00 p.m. ET on Saturdays in July during the activation periods (i.e. on July 2, 9, 16, 23 & 30, 2016, as applicable). activation and will not be entered into any draw. Redeemed Bonus Entries will accumulate over the course of the Promotional Period.

Invited Executive Coded Guests will have available 500 Bonus Entries each Draw Date for activation and entry into a draw. Bonus Entries must be redeemed between 10:00:00 a.m. ET and 9:00:00 p.m. ET on Saturdays in July during the activation periods (i.e. on July 2, 9, 16, 23 & 30, 2016, as applicable). Members can redeem Bonus Entries by swiping their Total Rewards card at the Promotions Kiosk or presenting their Total Rewards card to a Total Rewards representative at the Total Rewards Centre. Bonus Entries that are not redeemed as described herein will not be available for activation and will not be entered into any draw. Redeemed Bonus Entries will accumulate over the course of the Promotional Period.

- Seven Stars Members will be eligible to earn 100 Additional Entries for every 50 Tier credits earned during Earning Period Two;
- Diamond Members will be eligible to earn 50 Additional Entries for every 50 Tier credits earned during Earning Period Two;

Earning Period Three is from July 17, 2016 at 4:00:00 a.m. until July 30, 2016 at 4:00:00 a.m. ("Earning Period Three"). During Earning Period Three, members using their Total Rewards card during regular slot/table play will earn Additional Entries based on tier status as follows:

- Seven Stars Members will be eligible to earn 200 Additional Entries for every 50 Tier credits earned during Earning Period Three;
- Diamond Members will be eligible to earn 100 Additional Entries for every 50 Tier credits earned during Earning Period Three;
- Platinum Members will be eligible to earn 60 Additional Entries for every 50 Tier credits earned during Earning Period Three; and
- Gold Members will be eligible to earn 40 Additional Entries for every 50 Tier credits earned during Earning Period Three.

Earning Period Four is from July 30, 2016 at 4:00:00 a.m. until July 30, 2016 at 9:00:00 p.m. ("Earning Period Four"). During Earning Period Four, members using their Total Rewards card during regular slot/table play will earn Additional Entries based on tier status as follows:

- Seven Stars Members will be eligible to earn 200 Additional Entries for every 50 Tier credits earned during Earning Period Four;
- o Diamond Members will be eligible to earn 100 Additional Entries for every 50 Tier credits earned during Earning Period Four;
- Platinum Members will be eligible to earn 60 Additional Entries for every 50 Tier credits earned during Earning Period Four; and
- o Gold Members will be eligible to earn 40 Additional Entries for every 50 Tier credits earned during Earning Period Four.
- Earned Entries, Base Entries, Lump Sum Entries and Bonus Entries will accumulate over the course of the Promotion Period.

request received during Earning Period One and Earning Period Two and eighty (80) entries (requiring activation) for each eligible mail-in entry request received during Earning Period Three and Earning Period Four but no later than July 28<sup>th</sup>, 2016 ("Mail-In Entries."). The Sponsor is not responsible for lost or late mail.

In order to be eligible to be entered into a particular draw in the Contest, Members must activate Earned Entries, Base Entries, Lump Sum Entries, Bonus Entries and Mail-in Entries on the Draw Date in which they wish to participate between the hours 10:00:00 a.m. and 9:00:00 p.m. ET and at least sixty (60) minutes prior to the draw time (see Rule #2) in which they wish to participate using one of the following methods:

- a) Swiping their Total Rewards card at the Promotions Kiosk; or

The Representative will then announce the name and Total Rewards account number associated with each selected entry through the public address system at Caesars Windsor.

A Representative will then start a timer for five (5) minutes. If held, the Bonus Bank Draw at 10:30:00 p.m. each draw date will be drawn for until a selected entrant is identified.

It is the responsibility of each participant to hear the announcement over the public address system at the time of the announcement. The public address system cannot be heard in hotel towers, Colosseum, Neros, Ariius, parking structure, smoking shelters, or any areas outside of the Casino.

On each Draw Date at the 12:00:00 p.m., 1:00:00 p.m., 2:00:00 p.m., 3:00:00 p.m., 4:00:00 p.m., 5:00:00 p.m., 6:00:00 p.m., 7:00:00 p.m., 8:00:00 p.m., and 9:00:00 p.m. Draw Times, there will be one (1) prize available to be won of Cdn. \$10,000.00 cash ("\$10,000.00 Prize").

On each Draw Date at the 10:00:00 p.m. ET Finale Draw Draw Time only, there will be one (1) prize available to be won of Cdn. \$100,000.00 ("Finale Draw Prize").

Any unclaimed Prizes will roll over into the Bonus Bank Draw on the individual draw dates after the Finale Draw at the 10:00:00 p.m. Draw Time.

Total value of all prizes issued over 5 weeks is Cdn. \$1,000,000.00. (See chart below for breakdown of prizes)
