**1. How to Enter**

Caesars Windsor's 3 Chrysler Pacifica Hybrid Minivans & Cash Giveaway (the "Contest") begins on March 27, 2017 at 12:00:00 a.m. Eastern Time ("ET") and ends on April 22, 2017 at 10:00:00 p.m. ET. The Contest includes a draw on Saturday, April 22, 2017 ("Draw Date").

Eligible Total Rewards® Members ("Members") will receive a mailed notice (using the last known address recorded on their Total Rewards account) advising them of their eligibility to receive base entries ("Base Entries") (requiring activation as defined below) into the Contest on the Draw Date. The number of Base Entries that a Member is eligible to receive is based on his/her recognized tier status defined by Total Rewards as of March 1, 2017. Base entries for each tier are defined below:

- o Platinum Members will be eligible to earn up to 30 Additional Entries for every 50 Tier credits earned during Earning Period Two; and
- o Gold Members will be eligible to earn up to 20 Additional Entries for every 50 Tier credits earned during Earning Period Two.

Earning Period Three is from April 9, 2017 at approximately 4:00 am until April 22, 2017 4:00 am. ("Earning Period Three"). During Earning Period Three Members using their Total Rewards card during regular slot/table play will earn Additional Entries for each tier status are defined below:

Members are also eligible to receive entries by handwriting their complete name, mailing address, telephone number and Total Rewards card number along with a handwritten original essay one hundred (100) words or longer about why they like Caesars Windsor and mailing it in an envelope with proper and sufficient postage to 3 Chrysler Pacifica Hybrid Minivans & Cash Draws April 2017, c/o Marketing Events Department, Windsor Casino Limited, 377 Riverside Drive East, Windsor, Ontario, N9A 7H7. All mail-in entries must be original (no photocopies or other reproductions) and must be received no later than seven (7) business days prior to a Draw Date. Limit one (1) mail-in entry request per envelope per day. Members warrant that all essays are original and do not infringe the rights of any third parties. use of a Member's Total Rewards card to enter the Draw, whether caused by a technical malfunction of the card reader, computer or otherwise.

**2. Prize Draw**

On the Draw Date at approximately 5:00:00 p.m. ET, 6:00:00 p.m. ET, 7:00:00 p.m. ET, 8:00:00 p.m. ET, 9:00:00 p.m. ET, and 10:00:00 p.m. ET (each a "Draw Time" or collectively "Draw Times"), a Caesars Windsor representative (the "Representative") will randomly and electronically draw the appropriate number of entries at the Draw Time to correspond with the number of prizes available (see Rule #3). The Representative will then announce the name and Total Rewards account number associated with each selected entry from the Cosmos Rotunda area (the "Draw Site") as well as through the public address system at Caesars Windsor (which excludes the hotel towers, Colosseum, smoking shelters, parking structure, Neros, Arius, Elyx and any areas outside the Casino) and start a timer for five (5) minutes.
